Objectives

"This course provides students with high performance computational tools necessary to investigate problems arising in science and engineering with an emphasis on combining them to accomplish more complex tasks. A combination of course work and lab work will provide the proper blend of theory and practice. Problems to be investigated will be culled from the applied sciences."

Course Outline

The first class is on 8/31 (T) and the last class is on 12/2 (Th). Here is a tentative list of topics and schedule.

1. Linear Algebra

LU, QR, direct and iterative solvers, eigenvalues, SVD

- 2. Interpolation Lagrange, linear, cubic (1D), splines, hermite, Fourier
- 3. Approximation projection, least-squares, weighted orthogonal polynomials
- 4. Integration Newton-Cotes, Romberg, adaptive methods, Gauss, Monte Carlo
- 5. Differentiation error analysis, higher order methods
- 6. Ordinary Differential Equations linear multistep methods, Runge-Kutta methods, convergence, stiffness

Course Policies

Labs will address "bigger" practical problems. We will start getting our hands dirty during the lab hours; but you will be expected to finish up the lab at home.

Most assignments will involve using a computer. If you cannot submit an assignment on time, due to a legitimate reason, please inform me as soon as you can.
